

Commercial and Industrial Rate Options

Sales Service – Rates for customers purchasing gas supply from Nicor Gas

Rate 4 – General Service

Rate 4 is appropriate for small commercial and industrial customers with annual usage less than 1.2 million therms. Customers on Rate 4 utilize Nicor Gas for both the delivery and supply of natural gas.

Rate 6 – Large General Service

Rate 6 is generally economical for customers with annual usage above 1.2 million therms and high load factors. Rate 6 has a minimum monthly bill of \$3,500. Customers on Rate 6 utilize Nicor Gas for both the delivery and supply of natural gas.

Rate 7 – Large Volume Service

Rate 7 is generally economical for customers with annual usage above 10 million therms and high load factors. Rate 7 has a minimum monthly bill of \$8,900. Customers on Rate 7 utilize Nicor Gas for both the delivery and supply of natural gas.

Seasonal Usage

Rate 5 – Seasonal Use Service

Rate 5 is an appropriate rate for customers with annual usage less than 700,000 therms and with winter period gas usage representing no more than 5 percent of their annual usage. Customers with minimal winter period usage may find this rate attractive. Rate 5 customers utilize Nicor Gas for both the delivery and supply of natural gas.

Commercial and Industrial Rate Options

Transportation Service – Rates for customers purchasing gas from a third-party supplier

Rate 4 and Rate 5 with Rider 25 – Firm Transportation Service

Customer load profile and usage requirement are the same as Rates 4 and 5 above; however, customers purchase gas supplies from sources other than Nicor Gas, but retain Nicor Gas for 100 percent backup of gas supplies.

Rate 74 – General Transportation Service

Rate 74 is appropriate for small commercial and industrial customers with annual usage less than 1.2 million therms. Customers arrange for gas supplies from sources other than Nicor Gas. In addition, customers may elect varying levels of storage capacity and firm backup service.

Rate 76 – Large General Transportation Service

Rate 76 is generally economical for customers with annual usage above 1.2 million therms and high load factors. Customers arrange to purchase gas from another source and may elect varying levels of storage capacity and firm backup service. Rate 76 has a minimum monthly bill of \$2,600.

Rate 77 – Large Volume Transportation Service

Rate 77 is generally economical for customers with annual usage above 10 million therms and high load factors. Customers arrange to purchase gas from another source and may elect varying levels of storage capacity and firm backup service. Rate 77 has a minimum monthly bill of \$9,200.

Rate 75 – Seasonal Use Transportation Service

Customers with minimal winter period usage may find this rate attractive. Rate 5 customers utilize Nicor Gas for both the delivery and supply of natural gas.
